Under the AMCA Certified Ratings Program (CRP), we test products across our global network of labs and manually compare AMCA results to manufacturer test results. AMCA staff also manually checks manufacturer calculations, catalogs, sizing/selection software, and advertisements for conformance to CRP guidelines. AMCA invests heavily in marketing and communications to promote specification of AMCA-certified products among system designers, installing contractors, and building owners.
